

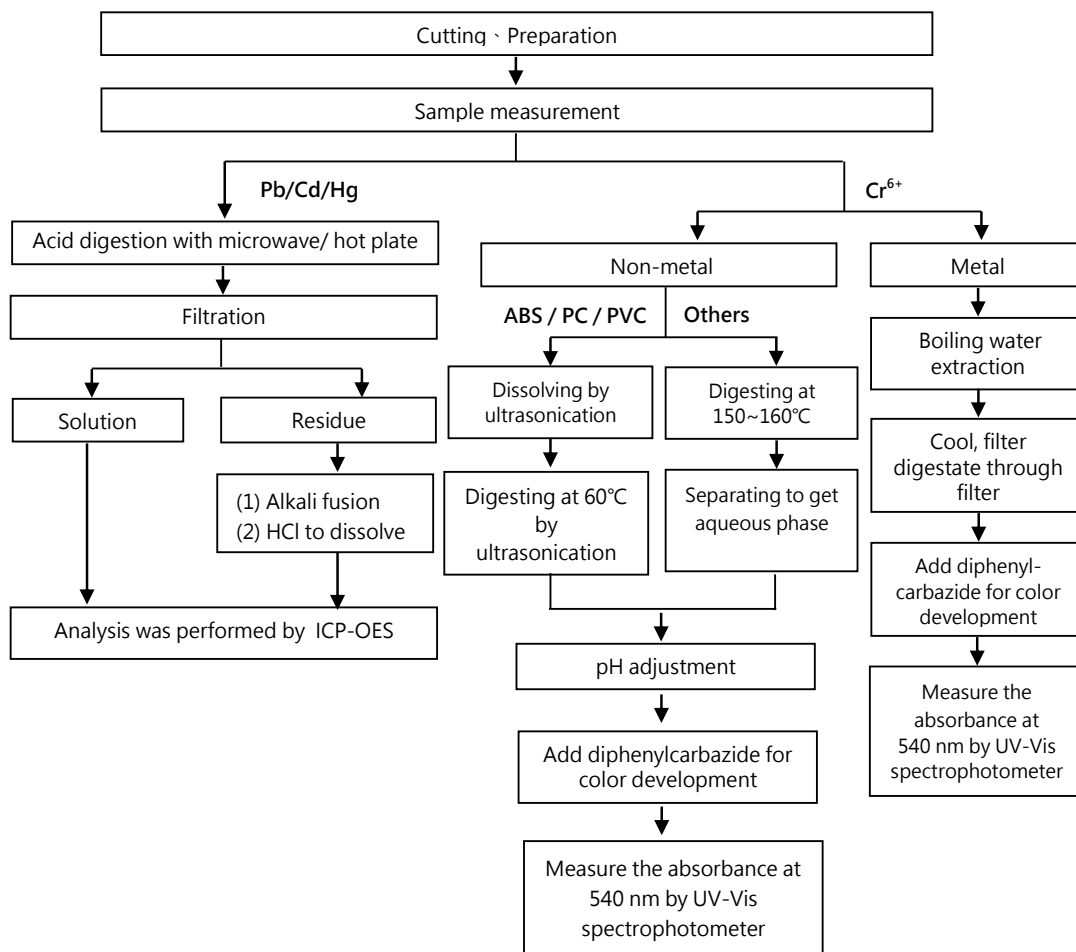

## Analytical flow chart of heavy metal

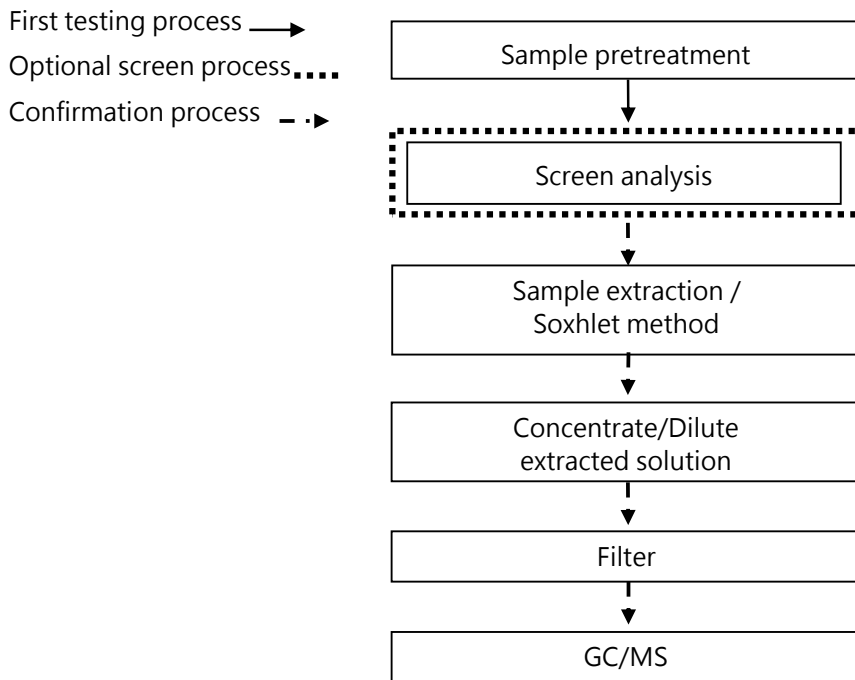

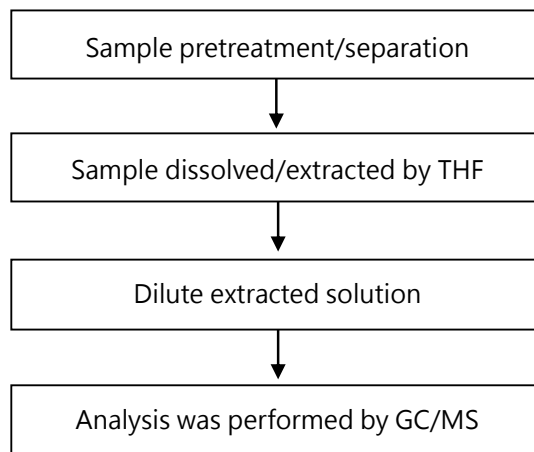
### Analytical flow chart – PBBs / PBDEs

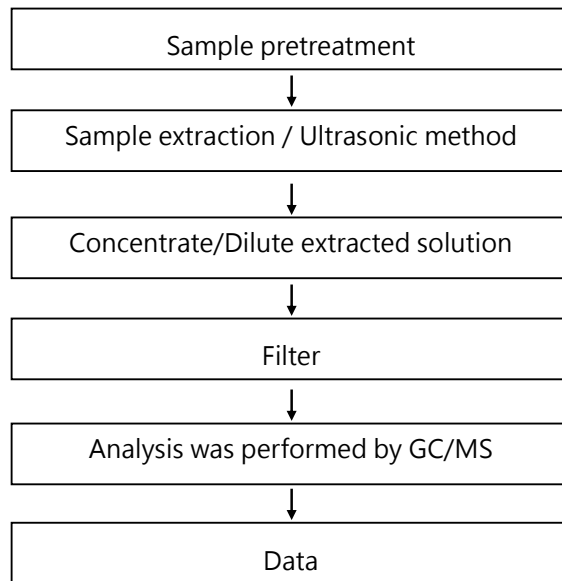

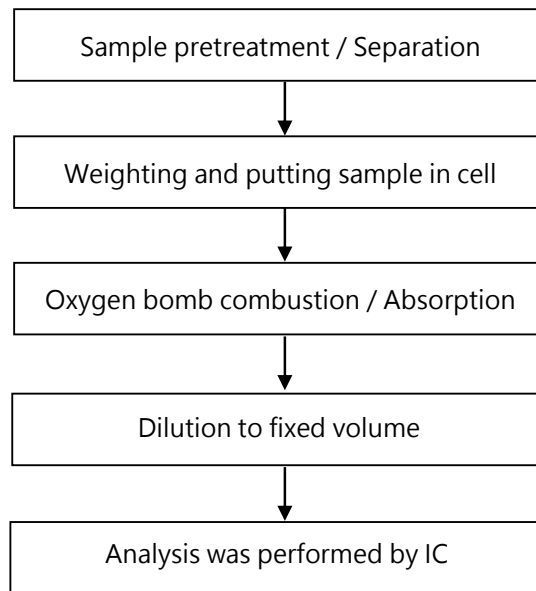
### Analytical flow chart - HBCDD

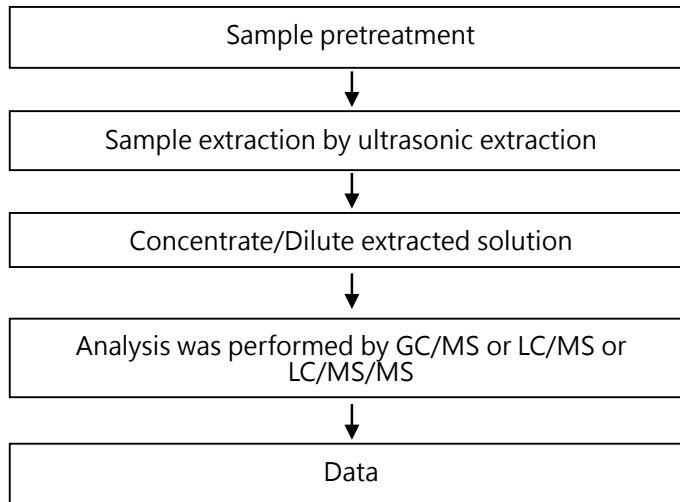


### Analytical flow chart - Halogen



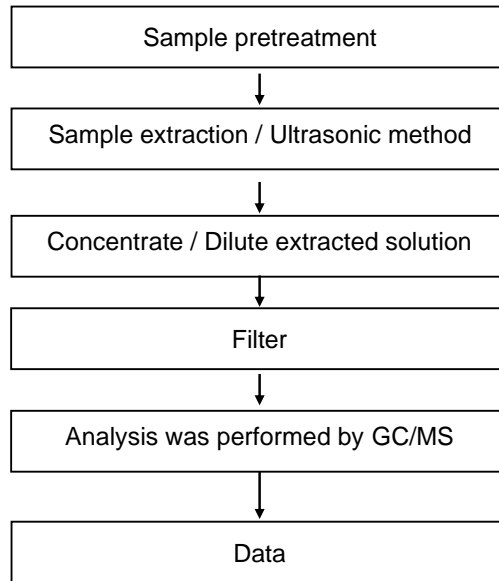

### Analytical flow chart - Dimethyl Fumarate

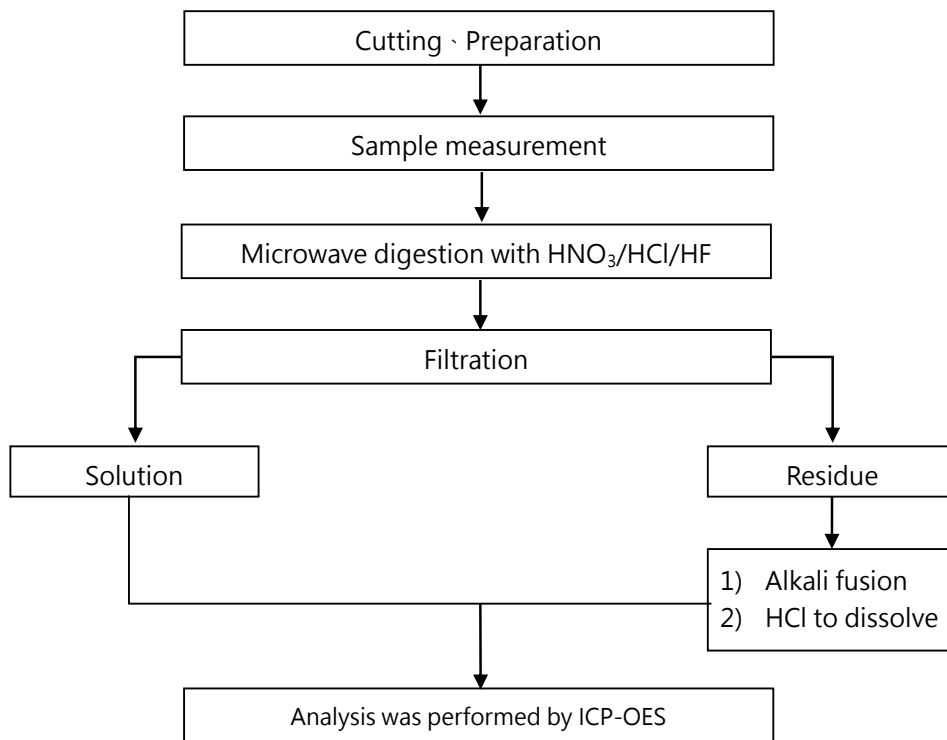

### Analytical flow chart of elements (Heavy metal included)

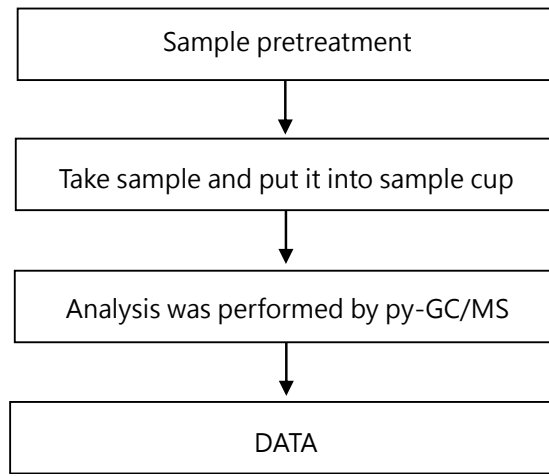

### Analytical flow chart - Red phosphorus

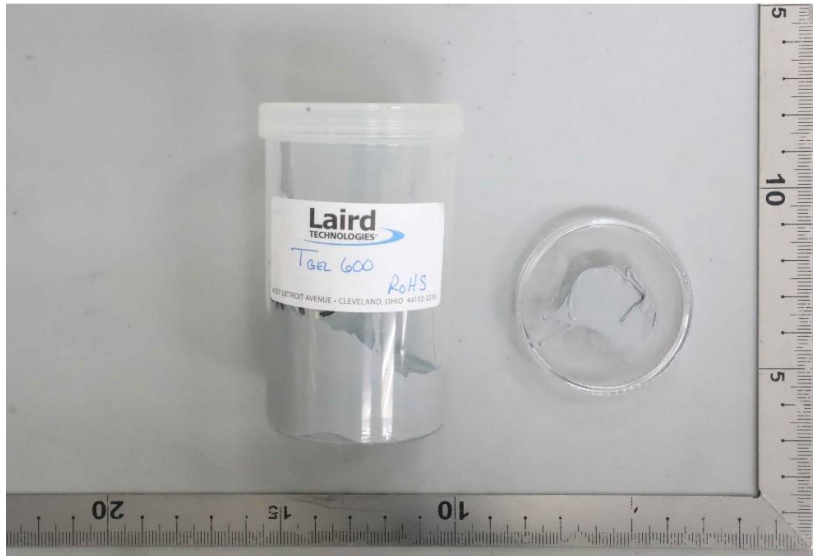
