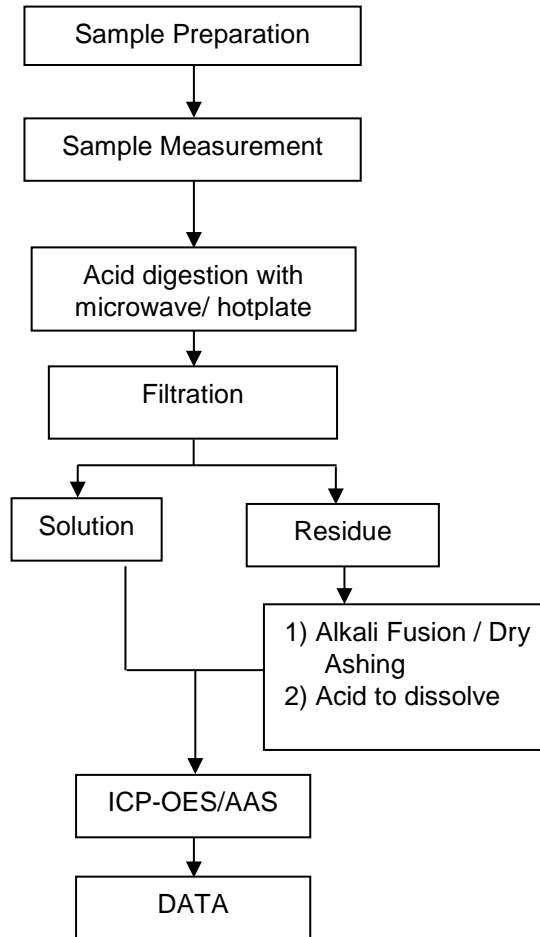

Elements Testing Flow Chart

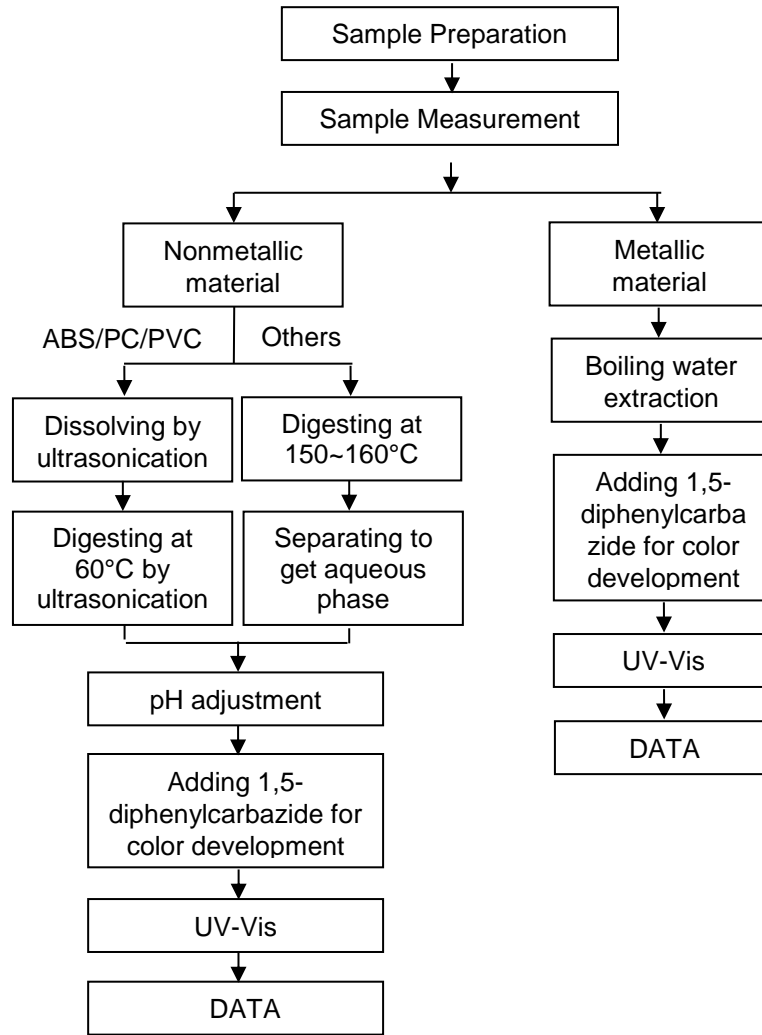

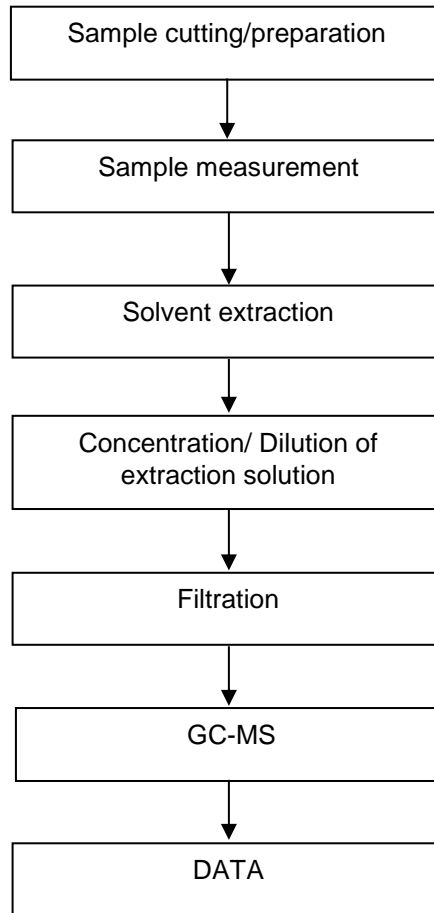

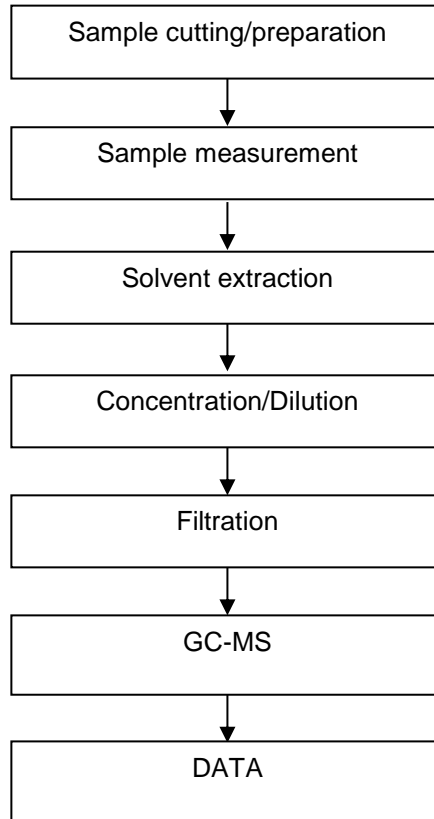
PBB/PBDE Testing Flow Chart

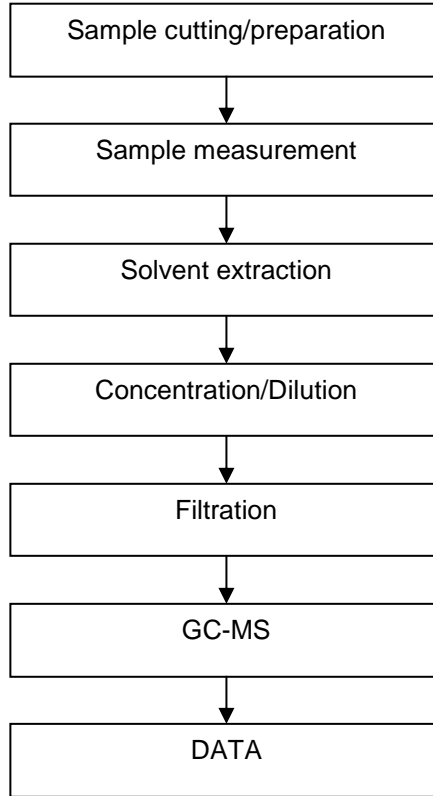
Phthalates Testing Flow Chart

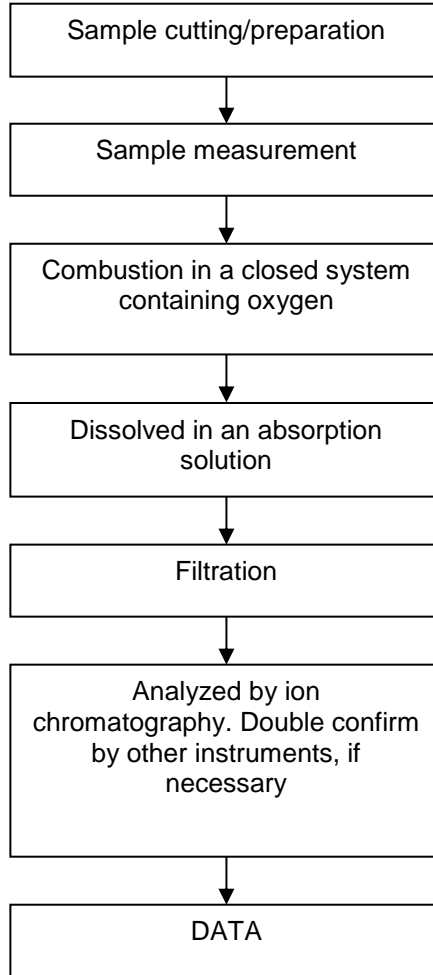
HBCDD Testing Flow Chart
